

PRIVACY POLICY

Introduction

COLLECTION OF PERSONAL INFORMATION

In order to provide any products or services, we will need to receive the following data from you, which will be used exclusively for administrative, legal or service-related purposes:

- Personal data: full name, address of residence, passport data, email address, phone, skype;
- Financial data: status of Investment and Bonus accounts.

USE OF COOKIES
